# Palestine: The British Mandate

A collection of sources from 1917-1940 on microfiche

This catalogue offers a comprehensive collection of sources which relate to the history of Palestine and which are rarely to be found in such completeness in most university-departments and research-institutes.

This collection covers the principal Memoranda, Statements and Reports published during the time of the British Mandate, from the Balfour Declaration in 1917 until the end of the Mandate in 1948. The collection includes the White Papers and Reports relating to the Official Commissions sent to Palestine.

The British reports to the Permanent Mandate Commission of the League of Nations have also been included, since Palestine was assigned to the League of Nations, Great Britain being the trustee.

Sources relating to the general social, demographic and economic development of Palestine have also been included.

The titles in this catalogue have been listed chronologically, as this seemed to be more useful for the researcher.

The legal aspects of Palestine have been microfiched as a separate project:

## Palestine: The legal background
